REQUIREMENTS FOR BOARDING

1. All animals must be current on all vaccinations. (Dogs- Dhlpp, Bordetella, Rabies and Influenza is recommended Cats- Fvrpc, Rabies)

a. All boarding clients must provide written proof of vaccination at check in. If unable to provide proof then pets will be vaccinated according to the guidelines above at owner's expense.

2. All animals must be free of external parasites (ex. ticks, fleas, etc.), or they will be treated at owner's expense.

3. Shores Animal Hospital has my permission to do whatever is necessary should an emergency arise with my pet.

4. If a tranquilizer is necessary for treatment or handling, Shores Animal Hospital has my permission to administer such medication. (This will be done at the owner's expense)

5. Pets may be picked up between 7:30am and 6:00pm Monday thru Friday, between 9:00am and 2:00 on Saturday, between 3:00pm and 5:00pm on Sunday. No pick ups are available outside of these times.

6. Payment is required when your pet is released to you or designated agent.

7. Prestige Pet Resort & Spa is not responsible for items left with your pet such as : (blankets, towels, toys, etc...)

8. We can not give your pet rawhides, pigs ears, hooves, or any treats of this type while boarding. These are considered dangerous toys.
